Term & Conditions

Terms

All initial orders are on a pre-pay basis. For your convenience we accept Master Card, Visa, American Express, Discover, Paypal and checks. Checks can be processed by phone or fax to avoid mail delays. Orders paid by check will be held until check clears. Terms are available for established commercial customers based on order and payment history.

Wholesale Application

All resellers and distributors must fill out a wholesale application. Additionally, culinary school and colleges or universities offering culinary or food service classes may qualify for a discount. If you are purchasing for a qualified educational facility, please fill out the Wholesale Application prior to placing an order.

Pricing Levels

30% discount - Available to qualified educational facilities.

40% discount - Available to qualified resellers who purchase a minimum of \$500 worth of retail product.

50% discount – Available to qualified resellers and distributors who purchase a minimum of \$1000 worth of retail product.

Please note that discounts apply to individually packaged items. They are not available for assortments and collections.

Re-order Level

Once you have qualified for the 50% discount, you will receive that discount on restocking orders that meet a minimum of \$200 worth of retail product.

Pricing

With the exception of the occasional sale or special, retailers carrying faerie's finest products agree to sell at the same retail price as found on our website.

Shipping

All shipments are FOB Hawaiian Gardens, CA. Orders are shipping via UPS or FedEx Ground unless otherwise specified. If you do not have an account with a carrier, you must pre-pay shipping charges prior to shipping.

Order Cancellation

faerie's finest must be notified of order cancellations by phone prior to noon PST on the day the order is scheduled to ship. We will not accept email notification for a cancellation. Because we manufacture and package for each wholesale order, cancellations will be subject to a 20% restocking fee.

Refused Shipments

Please notify us by phone if you find it necessary to refuse a shipment. Refused and returned shipments may be subject to a restocking fee plus any return shipping charges.

Shipment Discrepancies

If you find discrepancies in any shipment, please notify faerie's finest within five days of delivery.
